Court Reservation Cancellation Policy - If you need to cancel a court reservation that was made online, in person, and/or over the phone, we encourage that you do so a minimum of 4 hours before your reservation is scheduled to start.

If you do not cancel your reservation by its start time and you do not show up within 15 minutes of the reservation starting, a note will be added to your account indicating that you were a "no call and no show" for said reservation. If you receive more than 3 "no call no show" marks within a 6-month period, then you may lose your online reservation privileges for a period of time.

This policy is being put into place to encourage all patrons to inform us, with advanced notice, when they will not be able to use their previously scheduled reservation. COMING SOON you will have the ability to cancel your court reservation online. Once this feature has officially been released you will receive messaging informing you of the ability to cancel reservations online. We hope that the addition of this feature will add more convenience to the reservation cancellation process.

Inch by Inch: Ian McLaughlin

As an effort to get to know our membership the Board has decided to have a monthly column "Member Spotlight". We will be interviewing WCRC members and getting to know them. This article will help us find out how they got introduced to tennis, their background, any favorite memories, etc. We hope you enjoy this commentary.

This is the story of Ian McLaughlin. Ian was born in San Leandro in a Navy hospital, but his roots are deep in Walnut Creek. Both of Ian's parents grew up on Walnut Blvd in Walnut Creek, Ian's parents moved their family to Santa Rosa where Ian spent his childhood. After graduating from Law School and spending a few years at a law firm in San Francisco he decided that he wanted a different path, he wanted to be a Lawyer in Paradise, he took a job in Micronesia where he could do good and oh, dive in the prestigious world class waters of Palau. After 2 years he moved to Hawaii and worked for the Senate. And it was there, in Oahu, that he met his wife Starr. Soon after they married, had two boys, Sam and Charlie and moved back to Santa Rosa



His family would often come to see his grandparents in the Walnut Creek area.

"Hola mi hijo, did you bring your racquet?" This is how "Papa", Juan Carlos, would greet Ian every time Ian




and family arrived to visit him and his grandma Nini. Papa had built his own court in the back of his property where he helped Ian hone his skill and further develop the love of the game. Papa and Jimmy Connors were his tennis idols. Ian played tennis throughout his life, wherever he was, he found new friends to play tennis with. In 2005 Ian joined USTA in Santa Rosa and In 2007 Ian contacted the WCRC about playing tennis at Heather Farm. He connected with Tammie

Snyder, made it to a practice and soon found his way on to multiple teams. One of his favorite WCRC monuments was teaming up with Matt Starke to win the WCRC Double tille in 2016 over teammates Rob Corder and Terry

Hill. Ian was a machine, played singles and doubles and was dubbed "elevation sensation" by his teammate Sean Barnacascel.

In 2016 while making a presentation on Public health for the Non Profit that Ian worked for, he suffered multiple strokes. He has since fought a long and difficult battle on his road back, but he has never lost his appreciation for what he has, nor his sense of humor. When Ian first returned to the Bay Area his first stop was a Kaiser hospital in Vallejo. And as fortune would have it, the very first person Ian would see was his tennis teammate who was a Doctor at the facility, Scott Philipp. It was






warming to see a familiar face who provided a warm smile. After Scott reassured him that he was in good hands, he said "sorry, there is no ESPN on the TV." They both laughed, which was the first for Ian in a long while, but far from his last.

lan worked as a Lawyer in the nonprofit sector and has been an active member of the community, having been a member of the Parks Recreation and Open Space (PROS) Committee for the city of Walnut Creek. He has recently rejoined the community service ranks as a member of the County Transportation Advisory board. In addition, he is the author of the Member Spotlight for the WCRC.

Ian has made friends. long lasting ones throughout his life. One of his passions is backpacking. Often he would find his way to the trails with family and friends. One of lan's plans for next summer is to head up to the highlands in the summer of 2023 where he will be joined by some 20 guys from all eras of his life: school, college, professional. It's easy to understand how easy it is to be friends with this guy. A Son, a Grandson, a Father, a Husband, a Lawyer, a tennis player, a fighter and a survivor.

Team Orange - Audra Lutter, Cortny Christensen and Bob Satcher (this team had 4 of the drop outs) finished in 2nd place with 50 points.


Team White - Jisun Yoo, Rebecca Kay, Cy Lucas and Keane Tarrosa


I wanted to share a loss with our tennis community. Nina Gia Betts, age 52, of Pleasanton, California passed away on Saturday, September 24, 2022. Nina was born October 6, 1969. She is the wonderful and vibrant wife of Tom Betts.

About 2 ½ years ago, Nina was diagnosed with stomach cancer. Based on the location of the cancer, she opted to have her stomach surgically removed to avoid any metastasis to nearby organs. As the very fit and athletic person she was, Nina was out on the tennis courts only months following surgery. On Sunday, August 22, 2021 she played a full 3-set match partnering with Tom at Rudgear vs. a WCRC team. Their opponents and WCRC captain, Glenn McBee



were very supportive and encouraged Nina to regularly walk over to the side of the court and get some much-needed fluids throughout the match. Although she and Tom lost the match, she actually won her battle with the disease by going out on a hot day and playing the game she loved. Nina played on USTA teams for Pleasanton, PHTC and WCRC.

In late January 2022, they discovered in a scan that the cancer had returned and spread to the bone. Not surprisingly, on February 6, 2022, Nina made herself available to play a mixed match at PHMS with Tom. Despite the challenge she and Tom were facing, they played well and most importantly, they truly enjoyed the match and the moment. This was the last match she would play with us. I clearly recall her after the match, bravely sharing and accepting the



Over the next months, she and Tom travelled often to various parts of the world and truly enjoyed their long life together.

She and Tom have been extremely open and forthcoming throughout this ordeal and I am certain that he would appreciate you reaching out to call, text or email him during this difficult period. I last saw Tom on Tuesday evening during a USTA team practice. Over the last few months, Nina wanted him to remain active by playing tennis and pickleball.

Tom is a VERY fortunate man to have spent much of his life with such an open and courageous lady. He will always remember all of the wonderful and positive time he have spent with Nina.



Please have Nina, Tom and his family in your thoughts and prayers during this difficult time period.

MATCH FORMAT Best two-out-of-three set format.

A super tiebreaker can be played if all players agree, otherwise full third. Both teams responsible for bringing balls to match; winning team gets

the unopened can.

Matches should be played according to the "Rules of Tennis."

TOURNAMENT



End of season tournament with draw determined by league standings to be held over the weekend of Feb 3–5, 2023 dependent upon court scheduling and weather. To qualify for the tournament, teams must have completed and reported at least 2 matches during the regular league season. Depending on the number of entrants tournament play may include Friday night play. In addition, draws with large numbers of players may be required to play matches prior to the tournament weekend. Seeding for the tournament will be based on regular season standings of the top 4 teams in each divsion. The more matches you and your partner play, the higher your ranking will be. A minimum of 4 teams are required to generate a draw.

^{*} Teams with ratings more than 1 full step apart (i.e. 3.0 & 5.0 to make up an 8.0 team) are not eligible to play the end of season tournament.
