

Dear WCRC Tennis Friends,

As tennis players, you know, as we do, the value of this game of a lifetime and want to see it continued everywhere possible for young and old alike. Which brings us to the purpose of this letter.

The public tennis courts at the Pleasant Hill Middle School and the College Park High School are in a deteriorating condition and may soon become unplayable.

The middle school has an excellent tennis program for the 900+ students in their P.E. classes. The tennis club has events there every weekend. The courts are extensively used by the public

The high school site is used by 2000+ students for their P.E. program, as well as 850+ Valley View Middle School students; the girls' and boys' tennis teams play there. The PH Rec. and Park District has excellent tennis classes there. And, the public also makes extensive use of these courts, four of which have lights.

The PH Tennis Club has taken the lead to raise funds NOW to repair these courts. Sadly, the amounts needed to completely renovate them is not available at this time, and while the school and recreation districts will participate in funding this effort, it will depend on contributions from a great number of committed tennis players in our area.

Can we count on your support? A tennis friend once said, "Can we do it?"

With your help, and that of many others, we think the answer is YES!
