Tammie Snyder It Must Have Been The Watermelon Blow Pop

ammie Snyder is well known to everyone who is a WCRC member and anyone who has played tennis in the Bay Area. Her dedication to the racquet club and the game of tennis is an inspiration to us all. What would the Calcutta tournament be without Tammie's guiding hand and superior organization skills? But what do you really know about Tammie? Let's find out.

Tammie was born in Hollywood, CA and was raised with her 2 sisters in Pasadena and El Segundo. The laid back beachside community of El Segundo certainly helped to mold her personality and keen wit. In 1979 the family moved to Alamo when Tammie's father got a job in the Bay Area. Although the change from El Segundo was pretty dramatic Tammie was able to roll with it and hold onto her free spirit. She graduated from San Ramon High



and attended Cal State Hayward intending to take education classes and become a teacher.

Searching for a new direction Tammie quit taking school and worked at various jobs including a waitress at a Mongolian BBQ restaurant. 

In 1993 Tammie bought out Bryan's company and formed TLC Designs. Her full name was Tammie Lynn Coker hence the "TLC".

newsletter (of course she would!). Tammie joined the board and has held nearly every position at least once. In 2001 she became the driving force for the most loved tournament, the Calcutta. Her ability to juggle at least three balls at the same time has year in and year out contributed to the tremendous success of the Calcutta.

For Tammie, Heather Farm and the racquet club are a loving extension of her family. She, Justin and Logan have developed lifelong friends. There is also a compassionate and empathetic side to Tammie. Her current project in the works is BeUnderstanding. com, (website is currently under construction) that she and Logan masterminded together. As Tammie and Logan say "You don't have to understand, you just have be understanding".

Want a final picture of Tammie – when she was in her mid 20's she was riding her motorcycle out Tassajara and hit some loose gravel on the newly paved road. The bike went down and so did she. Tammie got major road rash on her elbows, knuckles, knees and half her face. Ouch! I can see her now, hair whipping in the wind and Born To Be Wild playing in the background.
