NEW USTA Class coming for Winter Session 2023! - We are pleased to announce that for Winter Session 2023 we will be piloting a class that will focuses specifically on 4.0+ players. Our very own Tennis Director Jeff Forbes and Lead Tennis Pro Kevin Huang will both be teaching the class. The class will focus on building match skills and strategies while offering some time for free play. To enroll in the class, you must be a 4.0 or higher rated player and must have previously played or currently play on a USTA Team. Warm up time before USTA Match - Please note that per USTA match rules, you are guaranteed 5 minutes of warm up time before your match. This time is already built into your match reservation time. If you would like to warm up on the courts before your match, you may do so free of charge up to 15 minutes before your match starts, as long as there are open courts available. If you would like to have longer than 15 minutes for a warm up, then you will need to book a reservation or walk on court and the standard \$6 fee becomes applicable. If you have a Lifetime Activities pass, then you will still need to book a warm up court, but the charge is not applicable to you.

Walk-On Court Process - Walk on courts are first come first serve only. In order to obtain a walk on court, you must come to the front desk with at least 1 other person that you will be playing with before you will be granted a court. Your reservation time will start at the time that you are granted the court, i.e. walk on court reservation time slots may be booked outside of the reservable court time slots. Please note that you are only allowed to book 1 court under your name per day. If you have already booked a reservable court under your name, then you will not be able to book a walk on court under your name during that same day. Hardwired to Compete: Glenn Teixeira

As an effort to get to know our membership the Board has decided to have a monthly column "Member Spotlight". We will be interviewing WCRC members and getting to know them. This article will help us find out how they got introduced to tennis, their background, any favorite memories, etc. We hope you enjoy this commentary.

CRC member Glenn Teixeira says that he's always been hardwired to compete and push himself hard, and that drive has taken him to some great heights in the game of tennis throughout his life. Glenn was a competitive junior player and played at Castro Valley High School in his hometown, where he finished No. 2 in Nor Cal. He grew up competing against Brad Gilbert (who he beat), once played John McEnroe (who beat him) and won the San Diego Open against Michael Chang when he was 25...and Michael was 12. He teamed up with his mother, a competitive



player herself, and the two of them reached the semifinals of the now-defunct mother/son division of the U.S. Open in Forest Hills, New York twice, in 1977 and 1978, where they finished



3rd both years. Glenn was awarded a tennis scholarship to San Diego State University and ended up spending the next thirty years of his life in Southern California.

Glenn's post-graduate career path led him to Alsco, a leading uniform and linen rental company based in Utah, where Glenn has done everything from sales to operations, and now serves as a Vice President/Regional Manager.



Glenn married his high school classmate, Nancy, although they ran in different circles and did not start dating until being reacquainted at their ten-year reunion. They have settled back in the Bay Area, except for their son Ross, who has been pursuing his Ph.D. in Computer Science at Princeton after completing his undergrad work at Cal Berkeley (Go Bears!).

With that exhaustive tennis resume, Glenn admits that at one point the game began to feel like a chore at times, and after he finished playing in college, he did not pick up a racket for five years. It was Nancy who convinced him to start playing



again, as she couldn't believe he had given up the sport that so defined him his whole life.

In 2018 Glenn found his way back to Northern California and landed for good in Lafayette and started playing at Heather Farm. During the craziness of moving between Southern California and Northern California, Glenn says that the tennis community "helped me stay sane." And spurred in part by the unexpected deaths of two of his best friends, Glenn has regained his appreciation for the game and his ability to compete and has learned to be less hard on himself and just enjoy the game more calmly (trying).

Glenn plays as often as he can and continues to excel

as one of the top ranked singles players nationally in the USTA 60+ division, in addition to competing in other USTA leagues and tournaments.

When he's not playing tennis or working, Glenn is an avid reader, traveler and loves following our Bay Area sports teams. Like so many of us at WCRC, Glenn is trying to strike the appropriate balance between competing at a high level and simply appreciating the game and the camaraderie of the amazing people who comprise the WCRC membership. Glenn says there is something special about the Heather Farm community....they're developing true friendships in the spirit of competition. ��

Moe loved to play any and all games, but was especially fond of Poker, Bridge, Shanghai and Canasta. She loved competition and even though she would say "I'm not competitive" she would happily take all of your money.

Moe loved to travel and go to places like Lake Tahoe, Reno, Mexico and Hawaii. Maui held a special place in her heart with visits almost every year.

She had a remarkable sense of humor and found the funny in most everything. She would say her happy place was sitting around her kitchen table laughing with her friends and family.

Duff Danilovich






