
# A Lifetime of Tennis: David Resnick-Dunn

Interview and article by Ian McLaughlin

As an effort to get to know our membership the Board has decided to have a monthly column "Member Spotlight". We will be interviewing WCRC members and getting to know them. This article will help us find out how they got introduced to tennis, their background, any favorite memories, etc. We hope you enjoy this commentary.

ifetime Activities' Walnut Creek general manager David Resnick-Dunn has spent much of his adult life working in the tennis industry, from which he brought a wealth of experience with him to Heather Farm when assumed the helm of Lifetime Activities' Walnut Creek facility in March 2022.

A Bay Area native, David grew up between the cities of Vallejo and Benicia, started playing tennis at age 8 and played on the Benicia High School Varsity tennis team, where he amassed a record of 34-2 in his two years playing singles. He then played intramural tennis at S.F. State while studying cinema at the university. David's first coaching job was at age 12 when he was an assistant coach at his local middle school. He began working full time in the industry at age 21 as a tennis instructor/office manager and spent 3 years working



for USTA NorCal as a Tennis Service Representative and later as Manager of the Junior Competition Department. When he learned of the opening with Lifetime Activities in Walnut Creek David applied in part because he was interested in gaining more experience in facilities management.

While David's real passion is coaching tennis, especially for beginners to whom the entire sport is




new, the responsibilities of his current position leave him with no time to coach anymore, but the deep understanding of players' needs that David gained through playing and coaching has given him a unique perspective on how to operate a facility that serves all the groups that are competing for limited court space and other resources. David feels that Walnut Creek is unique among Lifetime Activities' facilities because Heather Farm is very much like a community center where a committed group of consistent players gather regularly to hit the ball and socialize.

One of the biggest challenges for David has been that his tenure as general manager came precisely when Covid restrictions were being eased and all activities have resumed in person, requiring new procedures and protocols after his predecessor also had to develop new procedures and protocols when facilities were forced to abandon in person activities due to the pandemic just three years ago. David also has the typical challenges associated with running a busy facility, such as juggling the needs and desires of the various constituencies that are vying for court space and other resources. He credits his excellent staff for helping him learn the names of the club's many regulars.

David's parents still live in Benicia so he is able to see them regularly. David and his wife Priya and their cats Shadow, Midnight, and Simba live in Walnut Creek, and when he's not working David is an avid bowler, swimmer, and cyclist. He also continues to feed his creative side through film study and writing short stories. If you're looking for a movie recommendation from a guy who has actually studied cinema, David's favorite movie is a toss up between <u>Inglorious Basterds</u> and <u>The Shawshank Redemption</u>.

Finally, more than anything else since he joined Lifetime Activities, David has truly appreciated the patience and support of the WCRC tennis community as he continues to transition into his role as general manager and attempts to accommodate the needs and desires of all the players at Heather Farm. The community we're lucky to be part of at WCRC is only as strong as its individuals and the facility leadership, and we've found the right person with the experience to guide the club through the next phase of its development, meet GM David Resnick-Dunn. �

If a player is entering in more than one division, he/she may enter with the same partner or a different partner but may not enter with different partners at the same level.


The league runs from January 1, 2023 - May 26, 2023.


