Steven Anton Doss

Jan. 18, 1960 - Dec. 29, 2007

Long time WCRC member, Steven Anton Doss, 47, passed away at his own home in Rodeo on Dec. 29, 2007. The most important thing in Steve's life was his family, with whom he shared unconditional love. Born in Concord on Jan. 18, 1960, he attended Queen of All Saints School with his seven siblings. He graduated from Mt. Diablo High School.



Steve played baseball as a boy in Little League at Willow Pass Park in Concord a few blocks from home on Consuelo Road (where the family lived for 29 years). Then he made All-Stars, as the "fastest runner in Concord," moved on to Big Leagues, and became an avid tennis player, spending many hours at Cowell Park, Heather Farms and Diablo Valley College courts. He had many friends and fans.

Steve was an environmental contractor for 30 years. He called his thriving business "Aaron's Hauling," a name he picked to be first in the Yellow Pages. He had hundreds of loyal customers throughout the East Bay.

A Mass of the Resurrection to celebrate Steve's life was held at St. Peter's Catholic Church in Dixon, on Monday, Jan. 21. Father John Hannon officiated.
