In the next month or so we will be updating our annual directory. Take this time to log on and make sure all of your information is correct. It takes two seconds and will make editing the directory much easier.

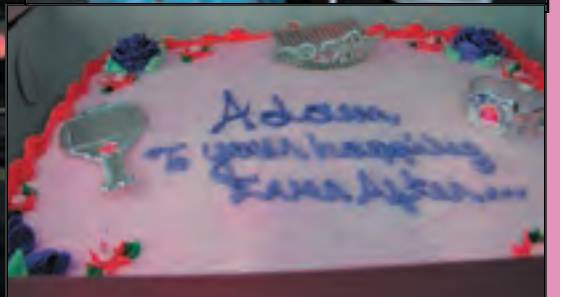
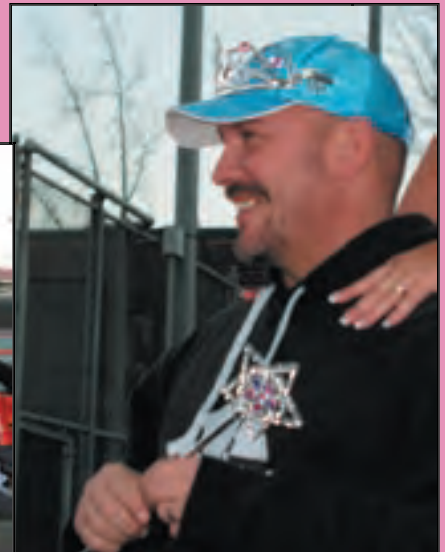
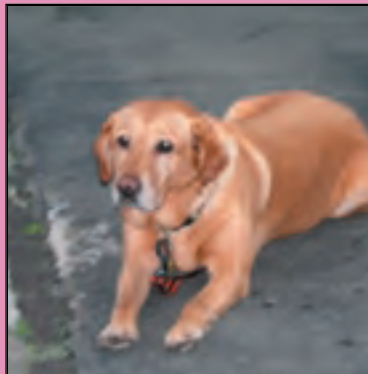
